SRTA Business & Transportation Updates – Sherry Welsh

- Reasons why riders might cancel at the door:
 - Due to late bus or because of weather conditions.
- SRTA has followed up on some bus stop concerns.
- The RFP for a van pool to help those with second and third shift employment has been narrowed down to one vendor. SRTA is hoping it will be running by fall.
- Bikes on shared ride bikes would be secured like any other mobility device.
- Fair collection technology 4 proposals are currently being reviewed.
- The Gettysburg fixture route summer schedule is live.
- The July fare increase mentioned at the May meeting has been postponed.

CCB quarterly update - Vernea Patterson Shaw January. February, March 2024:

- 380 new consumers from Upper & Lower Dauphin.
- 21,326 trips booked.
- 2,019 no shows.
- Mileage reimbursement was provided to 153 consumers totaling 5,028 trips.
- Out of county/premium trips: 345 capital city trips,18 Amtrak trips. 189 on Uber or Lyft, which they must schedule themselves.
- 24,592 incoming and outgoing calls averaging 381 daily.

April 2024 Capital Region:

Fixed route ridership: 107,355. Rider increase of 11,580 as compared to 4/2023.

• 52% on time, 27% late, 20% early.

Paratransit ridership: 10,790 total trips booked. 790 more than in 4/2023.

- No shows. 1,079 total = 9,711 trips completed.
- 78.8% on time, 21% late.

Customer service feedback – 38 total. 18 were MATP.

Performance Metrics

April 2024 York/Adams:

Fixed route ridership: 102,000. 11,718 rider increase as compared to 4/2023.

• 76% on time, 14% late, 10% early.

Paratransit ridership: 15,757 trips booked. 2,764 less than in 4/2023.

- 899 no-shows = 14,858 trips completed.
- 83% on time, 17% late

Customer service feedback – 104 total.

• Van was late, Driver missed stop.

Dauphin, York & Adams Call Center – 41,117 total calls. 30,322 answered, 10,795 dropped. 73.7% answer rate.
