SRTA has finalized the electronic transition from the CAT website to the Rabbit website only.

Statewide Independent Living Council - Jeff Iseman

- State budget On June 11th, 2024 the state budget was finalized. An additional \$80.5 million for public transportation, over \$40 million for multimodal which includes the shared ride programs and Amtrak.

SRTA Business & Transportation Updates – Damarr Lopez

• Free fixed route in Harrisburg and free shuttle from city island to the transfer center for National Night Out, August 6th, 2024, 5:30 to 9:00.

- SRTA was hoping for additional funds to go toward transportation. Legislatures
 claim that they never heard about transportation being underfunded. Rich Farr
 pointed out that transportation remains one of the top 3 issues of all community
 surveys. Legislatures responded by asking to hear from the constituents. SRTA
 is asking this group to help push for the additional funds. More info to come.
- Success in getting the RAISE grant to do the Harrisburg facility and transfer center improvements. The design is about 60% complete. The design team, as well as Rich Farr, will be at the September 18, 2024 meeting to present the concept and solicit feedback about any additions, improvements, or things to be aware of.
- Van pools for second and third shift employment- anyone can sign up, at least seven people with similar work locations will be needed to fill a van, the cost will be similar to fixed route costs. All vans will be accessible.
- Any fare increases are on hold for now.

Other Business:

Discussion about asking speakers of interest to this committee to speak at the meetings.

Unless the topics are concerning SRTA transportation, a separate meeting may be considered.

The June 2024 performance metrics were distributed via e-mail prior to this meeting.

Performance Metrics

June 2024 Capital Region:

Fixed route ridership: 97,479. Rider decrease of 186 as compared to 6/2023.

• 51% on time, 27% late, 21% early.

Paratransit ridership: 9,996 total trips booked. 269 more than in 6/2023.

- No shows 947 total = 9,049 trips completed.
- 98.17% on time,1.22% late.

Customer service feedback – 27 total. 21 were MATP.

Bus running late, no show, unprofessional.

Performance Metrics

June 2024 York/Adams:

Fixed route ridership: 115,431. 9,143 riders increase as compared to 6/2023.

• 76% on time, 9% late, 15% early.

Paratransit ridership: 14,432 trips booked. 316 less than in 6/2023.

851 no-shows = 13,581 trips completed.
 87.3% on time, 12.6% late

Customer service feedback – 114 total.

• Driver pass by, bus never came, unprofessional.

Dauphin, York & Adams Call Center – 28,917 total calls. 28,090 answered, 827 dropped. 97% answer rate.

York: 8 full time fixed route
7 Fixed Route 1 part time fixed route
1 Paratransit 3 full time paratransit
1 Class C Mechanic 9 part time paratransit
