#### MINUTES OF SRTA BOARD MEETING

October 31, 2024

#### CALL TO ORDER

Chairman Bugaile called the meeting to order at 10:00am.

#### CHANGES OR MODIFICATIONS TO THE AGENDA

A change was made to the Agenda to present the Fiscal Year 2023/2024 Audit after Communications.

Motion to approve the modification was raised by LaToya Winfield Bellamy and seconded by Keith Martin.

#### PUBLIC COMMENT

There was no public comment.

#### APPROVAL OF MINUTES

Motion to approve the September 26, 2024, meeting minutes was raised by Tom Wilson, seconded by Kirk Stoner, and passed unanimously.

#### COMMUNICATIONS

Representative Ed Neilson sent a thank you letter to Rich Farr for his presentation on the need for transportation funding.

#### AUDIT PRESENTATION

RKL conducted a presentation regarding the Authority Audit.

#### TREASURER'S REPORT

Steve Baldwin presented details on the September 2024 Financial Statement and Statistical Notes. He noted the following highlights:

# SUSQUEHANNA REGIONAL TRANSPORTATION AUTHORITY

- <u>RIDERSHIP</u>: Year-to-date comparisons to the prior year are as follows:
  - Fixed Route ran 3% above last year.
  - Paratransit was 8% above the previous year.
  - Commuter Express experienced a 5% increase from last year (YTD).
  - Microtransit's ridership was a 10% increase in ridership compared to the same time last year.
- <u>REVENUE</u>: September Year-to-date Grant and Contract Income is below budget by \$1.2 million because less subsidy was required than the budget anticipated.
- <u>EXPENSES</u>: Year-to-date Total Expenses are \$375,000 lower than budgeted.
- Unfilled positions decreased by (14) to a total of (49).
- <u>RESERVES</u>: The Authority's cash balances represent 180 days cash on hand. State Operating funds have been fully released to the Authority.
- LINE OF CREDIT: There are no draws on the organization's line of credit.
- CAPITAL EXPENDITURES (over \$50,000):
  - Paving of CDH bus barn floors \$100,000
  - Shop Equipment \$133,800
  - Computer Equipment \$83,570
  - o 1 Paratransit Vehicle \$140,841

After reviewing the dashboard and specifically the Preventative Maintenance (PM) on-time performance, Rich Farr announced two staff members have been hired to fill open positions in the Dauphin Maintenance Department, bringing the Dauphin facility to full staff in the maintenance department. There were over forty (40) PMs performed during the month of September. Tom Wilson recognized Rich and his team for their hard work.

- Review of the Act 44 Performance Review Action Plan.
- PennDOT has expressed that the new Dauphin facility project should be made more visible throughout the community. Planning has begun to hold a State of Transit session in the capital region in January. Plans include invitations to business leaders, Chamber members and elected officials to discuss the importance of the project.
- Staff will begin preparations to begin the process for updating the Strategic Plan.
- A new fare collection system is advancing. Staff will present a new fare policy to the Board in the near future.
- rabbittransit will provide rides at no cost to fixed route riders on Election Day to York County residents, as Shiloh Baptist Church sponsored the trips.
- Driver assaults continue to be a challenging concern. The Authority is expanding its de-escalation training for drivers.

# AUTHORIZATION TO ENTER INTO CNG FUELING FOR TRANSIT AGENCIES PARTNERSHIP PROJECT AGREEMENT WITH PENNDOT

WHEREAS, the Susquehanna Regional Transportation Authority (SRTA) wishes to convert some or all of its fleet vehicles to accommodate compressed natural gas (CNG) through future vehicle purchases; and

WHEREAS, the Pennsylvania Department of Transportation (PennDOT) has established a Public-Private Partnership Project with Trillium Transportation Fuels, LLC to provide CNG fueling solutions to transit agencies across the Commonwealth, and

WHEREAS, PennDOT and Trillium Transportation Fuels, LLC have entered into a Public-Private Partnership Agreement for designing, constructing, financing, operating and maintaining CNG fueling stations and upgrading maintenance facilities; and

WHEREAS, SRTA's participation in the project requires entering into a Transit Agency Agreement (Agreement No. CNG-TAA-SRTA-0032) with PennDOT; and

WHEREAS, the Agreement establishes the roles, responsibilities, and obligations of both SRTA and PennDOT regarding the CNG facilities, including but not limited to:

- Project site access rights
- Natural gas supply arrangements
- Environmental and hazardous materials responsibilities
- Fueling windows and dispatch times
- Payment terms including the CNG Availability Charge
- Governmental approvals and permits

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of SRTA that the Chairman and/or Executive Director is hereby authorized to Agreement No. CNG-TAA-SRTA-0032 with the Pennsylvania Department of Transportation for the CNG Fueling for Transit Agencies Partnership Project. The Chairman and/or Executive Director is further authorized to execute any additional documents and take any additional actions necessary to implement and effectuate the Agreement.

# Parties

# Purpose

To establish a partnership enabling SRTA to convert its fleet to compressed natural gas (CNG) through PennDOT's Public Private Partnership with Trillium Transportation Fuels, LLC ("Development Entity")

# **Project Scope**

- Design, construction, and maintenance of CNG fueling stations
- Upgrade of existing maintenance and storage facilities to be CNG-ready
- Implementation of CNG fueling operations
- Potential commercial sales to non-transit customers

# Key SRTA Responsibilities

# Site Access

- a. Provide access to project sites for construction and maintenance
- b. No additional restrictions beyond those specified

# **Natural Gas Supply**

- a. Enter into natural gas supply contracts
- b. Monitor gas quality and content
- c. Coordinate with utility providers

# Environmental

- a. Manage hazardous materials not caused by Development Entity
- b. Maintain necessary environmental permits

# **Financial Terms**

# **CNG Availability Charge**

- a. \$0.60 per GGE (Gasoline Gallon Equivalent)
- b. Indexed to CPI annually starting January 1, 2017
- c. Billed annually by PennDOT

# **Term & Termination**

- a. Agreement terminates upon:
  - a. PennDOT's notice of PPSA termination
    - i. Removal of project site from scope
    - ii. Completion of agreed-upon term

# **Risk Allocation**

- a. Development Entity responsible for construction and operational risks
- b. SRTA responsible for environmental conditions not caused by Development Entitiy

# **Commercial Sales Option**

- a. Development Entity has exclusive right to commercial sales
- b. If not implemented within 5 years of CNG readiness, SRTA may authorize other vendors and commercial sales must not interfere with transit operations

This agreement is part of PennDOT's larger initiative to promote CNG use in public transit across Pennsylvania, providing SRTA with necessary infrastructure while sharing costs and responsibilities among multiple parties.
